The candidate hired for this position will work directly with our Research Associates, Assistant Researchers, Project Manager and Managing Director to conduct community economic development-focused data collection operations, complete varied market analysis and targeted feasibility studies, develop local and regional economic development plans and strategies, and draft topicspecific as well as community-centered research reports. The selected candidate will also deliver presentations to facilitate economic development planning processes for our clients and tailor materials to further our clients' specific advocacy and policy-related efforts.

In addition, this position will require the patience, maturity, perseverance, and diplomacy necessary to operate within the complex and dynamic cultural contexts of tribal, rural, and urban areas as well as the "soft" skills necessary to build and sustain vital partnerships and coalitions, all while maintaining the highest standards of data analysis, reporting and presentation. The ideal candidate will be eager to travel to and work in very rural and remote areas, including tribal lands from Arizona to Alaska and Hawaii to

Wisconsin, and be excited to serve as a thought leader and the face of the organization at relevant meetings and conferences.
